## **Other Terms and Conditions of the Student Enrollment Agreement**

1. FOR CraniumPARTY: \$ 100 non-refundable deposit is required to secure a spot. Remaining payment is due/paid during the party.
  2. FOR CAMPS: The Responsible Party is responsible for paying all monies listed above whether or not the student attends the programs/classes/sessions listed above and for which payment is due. On or before 30 calendar days before the child's first camp will start a parent can send written notification to cancel the camp enrollment and receive a refund less ten percent (10 %) of the tuition fee back (no refund of registration fee). Within 30 calendar days before the start date of your student's camp, there will be the potential for the same refund terms as long as any/all of the summer camp spots the student has signed up for can be filled (no refund if the spot can not be filled).
  3. If any payments due under this agreement are not paid when due, the student may be denied the right to attend classes without altering any of the financial obligations of the Responsible Party. Should any payments be rejected, due to insufficient funds, Cranium Clubhouse, Inc. reserves the right to refer the matter to a collection agency.
  4. All costs and expenses, including reasonable attorney's fees, incurred by Cranium Clubhouse, Inc. in order to collect any amounts due under the Agreement, or to remedy any other breach of this Agreement by the Responsible Party, will be borne by the Responsible Party.
  5. If the Responsible Party wishes to have the Student picked up by someone other than those specifically listed in this agreement, the Responsible Party will provide Cranium Clubhouse, Inc. with written authorization allowing the third party to pick up the child. The Responsible Party understands and acknowledges that they are aware of what time they need to pick up their Student (child/children) and that it is their complete responsibility to have either themselves or someone else physically present at and in the facility to pick up their Student (child/children) on or before the time when the program/class/session is complete and/or lets out. On behalf of myself and my Student (child/children) and acting as the Responsible Party I understand that it is my sole responsibility to have the appropriate person physically present at and in the facility to pick up my Student (child/children) and I agree to indemnify and hold harmless Cranium Clubhouse, Inc., its owners, operators, instructors, employees, agents and servants from any and all responsibility and liability in regards to my Student (child/children) being picked up from and/or leaving the facility.
  6. If a Student, Parent, Responsible Party or anyone associated with the Student, in the sole judgment of the teacher, teaching assistant or administrative staff, causes disruption in the classroom or facility or in any other way detracts from the other student's ability to maximize their learning opportunities, the Student may be dismissed from the program. This agreement may be terminated by Cranium Clubhouse, Inc. for any reason and if terminated by Cranium Clubhouse, Inc. the Responsible Party will be refunded for any classes/sessions not attended and will not be refunded for any enrollment fees and/or classes/sessions previously taken.
  7. The Responsible Party acknowledges and agrees that the Student may be video taped, filmed or photographed during classroom activities, and hereby authorizes Cranium Clubhouse, Inc. to use the parent's and student's name and any resultant likeness of the Student in its advertising or promotional materials or otherwise without compensation and gives permission for their Student to take part in all activities associated with Cranium Clubhouse, Inc.
  8. I/we (responsible party) understand the nature of the physical, gymnastic, athletic and all other activities that our student/child will participate in at Cranium Clubhouse, Inc. and attest that the student/child is qualified, in good health and in the proper physical and mental condition to participate in such activities.
  9. Every term and provision of the original agreement and this addendum is intended to be severable. If any portion hereof is found to be invalid or unenforceable, the remaining terms and provisions shall continue in full legal force and effect.
  10. For any program/classes/sessions/time/camp and especially CraniumPARTY where the Responsible Party invites or takes other children to the facility, The Responsible Party acknowledges that they take full responsibility for those other children and that all conditions stated above will apply to any/all other children they invite or take to the program(s) or facility. For a CraniumPARTY the Responsible Party understands that each child they invite should have an accompanying parent who stays at the facility for the entire party and if they leave then the entire responsibility for that child is with the Responsible Party who is hosting the party.
- I/we (responsible party) understand that if our student (child/children) is dropped off at the facility we give Cranium Clubhouse Inc employees temporary guardianship for the time that our student (child/children) is at the facility as long as any/all of them are at the facility. In the event the Responsible Party or Emergency Contact(s) can not be reached or in an emergency, the Responsible Party gives permission to Cranium Clubhouse Inc., its owners, operators, instructors, employees, agents and servants to seek out and give any emergency or medical care they feel is needed for the Student and this permission is also given to any physician, hospital or person(s) selected by Cranium Clubhouse Inc., its owners, operators, instructors, employees, agents and servants. I/we (responsible party) hereby agree to assume complete responsibility for any costs, medical or other incurred by my Student (child/children) while under Cranium Clubhouse Inc., its owners, operators, instructors, employees, agents and servants supervision. On behalf of myself and my Student (child/children) and acting as the Responsible Party I agree to indemnify and hold harmless Cranium Clubhouse Inc., its owners, operators, instructors, employees, agents and servants from any and all claims, demands, costs, expenses and compensation arising out of or in the course of or in any way related to any personal injury to me or to my Student (child/children).
